# Golioth, Inc. Golioth September Sweepstakes Rules ("Official Rules")

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE SWEEPSTAKES IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW. #### 3. How to Enter

#### **Newsletter Sign Up Entry**

**Step 2**: Subscribe to the newsletter by submitting the requested information on the Sweepstakes Website.

You may obtain a maximum of one (1) entry to participate in this Sweepstakes. Entries generated by script, macro, mechanical or other automated means are void. Multiple entries received from any person in excess of the stated limitation will be void. Multiple participants are not permitted to share the same phone number, email address or device used to enter. Any attempt by any participant to obtain more than one (1) entry by using multiple/different devices, identities, or any other methods will void that participant's entries and that participant may be disqualified from the Sweepstakes. In the event of a dispute as to any entry, the authorized account holder of the device used to enter will be deemed to be the entrant. A potential winner may be required to show proof of being the authorized account holder.

## 4. Odds of Winning

Odds of winning depend on the number of eligible entries received.

#### 5. Winner Selection and Notification

Within five (5) business days of the conclusion of the Sweepstakes Period, one (1) potential winner will be randomly selected from among all eligible entries received to receive the Prize. Golioth will notify the potential winners via the e-mail used to sign up for the newsletter in Section 3. The potential winner is subject to verification of eligibility, including verification of residency.

If a potential winner (i) is determined to be ineligible or otherwise disqualified by Golioth or (ii) fails to respond to Golioth's first winner notification message within five (5) business days of notification or after two (2) attempts (whichever occurs first), the potential winner forfeits the prize in its entirety and, if time permits, a substitute potential winner will be selected based upon a random drawing from among all other eligible entries received for the Sweepstakes during the Sweepstakes Period.

All decisions of the arbitrator shall be final and binding on both parties and enforceable in any court of competent jurisdiction. Notwithstanding this, application may be made to any court for a judicial acceptance of the award or order of enforcement.
